Public Comments

 Carol Boyce (13 Washington Place) informed the council that she had called neighboring towns to discuss their deer feeding ordinances/practices. Most towns have monetary penalties for feeding deer within city limits.

Unfinished Business

- Department Reports
 - Law Enforcement, Fire Department, Public Works & Code Compliance Reports were presented by representatives from each department.
- Investment Update
 - City Clerk Nevsimal has successfully transferred \$500,000 into a Federal Home Loan Bank Bond with a yield of 4.75% callable on 12/8/2023. The interest payout will be approximately \$23,750 payable in December 2022, June 2023, and December 2023. The interest payment in December 2022 was \$4,531.25.

- Ordinance 597-2022, 2023 Final Budget
 - A motion was made and seconded to approve Ordinance 597-2022, Adopting the Budget for the Fiscal Year Ending December 31, 2023.

- Police Contract
 - The police contract with Coulee Dam has been signed around between both cities' mayors, city clerks and attorneys and will begin on January 1, 2023.

- Swearing in of Park Committee

- TIB Grant Discussion
 - The City of Electric City has received two Transportation Improvement Board Grants for 2023-2024, A \$37,350 grant for crack sealing and an additional \$335,054 grant for chip sealing and seal coating.
- Mosquito District #2
 - A motion was made and seconded to grant permission for Mosquito District #2 to conduct field surveillance along with ground and aerial application of mosquito control products.
