# **Public Comments**

No public comments were submitted to the Mayor or City Clerk before the meeting.

## **Unfinished Business:**

- Streets Projects, Phase 1:
  - The pedestrian beacon system and signage have been installed.
  - The two items left to complete on the final punch list are to take post-construction photos of the entire project and submit record drawings.

- Wastewater Treatment Plant Invoice:
  - The council members on the Wastewater Committee (Buche & Hoffman) would like to meet with the council members in Grand Coulee, who are also on the Committee, to determine what portion of the monthly bill each City should pay. The Electric City Clerk will coordinate setting up that meeting.
- Lift Station Award Process:
  - Steve Nelson from Century West Engineering, Mayor Kohout, and Public Works Director Armstrong were present for a live bid opening on May 1, 2020. A total of four bids were received.
  - A motion was made to accept TEK Contracting's bid and award the Lift Station Replacement Project to them.

- Park Street tree removal
  - Basin Vegetation Management is under contract with Grant County PUD to remove the tree at 220 Park Ave. Once the tree has been removed, the City is responsible for having the stump removed.
  - o A motion was made to approve the stump grinding expenses.

COVID-19 Ordinance extensions were extended by the Office of the Governor's proclamation 20-23.3.
 This supersedes all local resolutions and ordinances and suspends late fees and shut offs of utilities.

### **New Business**

- Extending Resolution 2020-07 to 2020-11:
  - A motion was made to pass Resolution 2020-11, which extends Resolution 2020-07's expiration to May 31, 2020.

- Streets Project, Phase 2:
  - The council discussed a variety of options for phase 2 of the streets project.
    - All agreed that "bulb-outs" were not wanted along any new sidewalks.
    - A flashing light/crosswalk would be beneficial at the intersection of Electric Blvd and Hwy
       155 where there is heavy pedestrian traffic.
    - o A boundary survey will be included as part of the Engineering Consulting agreement.
    - A motion was made to accept Century West Engineering's consulting agreement.

- Office Summer hours:
  - City Clerk/Treasurer Nevsimal and Deputy Clerk Parrish presented new summer hours. The clerks will each work four 10-hour days from 7:00am until 5:30pm with Nevsimal having Mondays off and Parrish having Fridays off. The clerks will stagger their lunch time so that the office will remain open continuously from 8:00am until 5:00pm, Monday through Friday.
  - A motion was made to approve the Clerks' new summer schedule.

- Acceptance of gifts:
  - A motion was made that before any donation or gift of real or personal property to the city shall become effective, the city council will adopt a resolution confirming the city's acceptance of gifted or donated property.

- Code variance and non-conforming requests:
  - The council discussed a variety of requests that have been received at City Hall regarding code variances and non-conforming items.
  - The council agreed that re-forming a Planning Committee, which was dissolved several years ago, would be beneficial.
  - The City currently has a code variance form that can be picked up at City Hall and filled out by a resident seeking a non-conforming item.
  - o The council would like to review ordinances that have been adopted within the last five years.
- Rehiring on volunteer fireman:
  - o A motion was made to rehire Ken Dexter as a volunteer fireman.
