A RESOLUTION AMENDING RESOLUTION NO. 2018-10  
SIX YEAR TRANSPORTATION IMPROVEMENT PROGRAM 2019-2024

WHEREAS, pursuant to the requirements of RCW 35.77.010, Laws of the State of Washington, the City of Electric City, WA has prepared a revised and extended Six Year Transportation Improvement Program for the ensuing six calendar years, 2019 through 2024 which was adopted by Resolution 2018-10; and,

WHEREAS, the City Council of the City of Electric City, WA, desires to amend the Six Year Transportation Improvement Program as a requirement of certain funding agencies for the ensuing six calendar years, 2019 through 2024; and

WHEREAS, pursuant further to said law, the City Council of the City of Electric City, WA, being the legislative body of said City did hold a Public Hearing on said improvement plan at 5:45 p.m. at the City Hall in Electric City, WA on the 12<sup>th</sup> day of June 2018 and the 11<sup>th</sup> day of June 2019.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Electric City, WA, that the amended Six Year Transportation Improvement Program for the ensuing six calendar years 2019 through 2024 as detailed in the attached Exhibit A, be and the same is hereby adopted; and,

BE IT FURTHER RESOLVED, that a copy of said revised and extended Six Year Transportation Improvement Program for the ensuing six calendar years, 2019 through 2024, together with a copy of this Resolution, be filed with the Secretary of Transportation of the State of Washington.
